National Headlines – Counter terrorism education

Firearms or weapons attacks are thankfully rare in Devon, however, in the unlikely event of a terrorist attack, being prepared and knowing how to respond is really important and may save lives.

Attacks in the UK and abroad remind us all of the terrorist threats we face. Police and security agencies are working tirelessly to protect the public but it is also important that communities remain vigilant and aware of how to protect themselves if the need arises.

On 28 September 2017, 'Act For Youth campaign' launches in partnership with News UK, designed to help educate 11 to 16 year olds on how to stay safe in the event of a firearms or weapon attack. Key advice is to follow 'Run, Hide, and Tell' guidance until Police arrive on the scene, but research shows that this messaging is not always effectively reaching younger audiences.

Counter Terrorism Policing and celebrity influencers, including Bear Grylls, have been participating in activities across the country as part of the campaign launch to raise awareness amongst young people about how to stay safe.

I would encourage all parents and guardians to read through the guidance with their sons and daughters.

RUN

- Escape if you can
- Consider the safest options
- Is there a safe route? RUN, if not, HIDE
- Can you get there without exposing yourself to greater danger?
- Insist others leave with you
- Leave belongings behind

HIDE

- If you cannot RUN, HIDE
- Find cover from gunfire
- If you can see the attacker, they may be able to see you
- Cover from view does not mean you are safe, bullets go through glass, brick, wood and metal
- Find cover from gunfire e.g. substantial brickwork / heavy reinforced walls
- Be aware of your exits
- Try not to get trapped
- Be quiet, silence your phone and turn off vibrate
- Lock / barricade yourself in
- Move away from the door

Call 999 - What do the police need to know? If you cannot speak or make a noise listen to the instructions given to you by the call taker

- Location Where are the suspects?
- Direction Where did you last see the suspects?
- Descriptions Describe the attacker, numbers, features, clothing, weapons etc.
- Further information Casualties, type of injury, building information, entrances, exits, hostages etc.
- Stop other people entering the building if it is safe to do so

Safeguarding monthly focus – Parental controls

Parental controls are designed to help protect children from inappropriate content they may come across online, such as pornography. These controls can be used to limit access to only age-appropriate content, to set usage times and to monitor activity.

There are four main places you can find parental controls, and it can help to set up a combination of these:

- Internet provider: you can set up filters to help block access to inappropriate content on any device that connects to your home WiFi
- Mobile operator: filters are often automatically set up on mobile contracts, but you can double-check with your provider
- **Devices:** many devices have parental control settings, for example, to help restrict spending in apps or disable location functions
- **Online services:** sites like BBC iPlayer and YouTube have parental control settings to help restrict access to inappropriate content

There is also a growing concern nationally in regards to the amount of time spent on electronic devices at bed time. Statistics show that 75% of children sleep with a device in their bedrooms. Increased time spent on devices at bedtime can lead, in some cases, to increases in low mood, increased anxiety levels and a reduction in academic progress due to fatigue. The new app below is designed to give back control to parents.

OurPact

OurPact is a breakthrough parental control app that enables parents to manage their family's screen time through Internet and application blocking. Our parental control solution allows parents to manage their child's screen time by blocking specific apps, blocking texts, and scheduling screen time according to a child's daily routine.

Please see below a reminder of the apps to look out for when monitoring the internet use of your son/daughter. I would encourage all parents to be valiant and report concerns to CEOP in regards to the following apps;

Roblox is a user-generated massively multiplayer online social gaming platform, dubbed the 'new Minecraft'. In the game, players are able to create their own virtual worlds within the platform, and invite others to join. Activities in the game world include exploring, crafting items, resource gathering, and combat. The game can be played on mobiles, tablets and computers.

A recently added chat facility on the site means strangers can message young players directly and chat to them, with no age verification

AMINO - **COMMUNITIES, CHAT, FORUMS, AND GROUPS** is an app that lets users access and contribute to communities about a range of subjects, including bands, books, genres, and activities. ... When you tap a community, you can view its description, community guidelines, and the number of registered users in that group.

Like many apps there are risks involved for children as there is a chat facility and obviously would be an ideal platform for grooming to take place.

MovieStarPlanet is an online game with a social networking aspect, which is popular with 8-13 year olds. The game allows children to customise a movie star character and explore a virtual world with a movie star theme. Children are able to make animated films, design art books and play online games. The social networking aspect of the game allows users to use chat rooms to make contact with other users. There are a range of safety features and advice available.

In the previous month numerous reports have been noted where adults are contacting children via this app for the purpose of grooming and acquiring indecent images.

There is no minimum age requirement; however the app is aimed at children aged 8-15 years.

The makers of a controversial app, which the NSPCC fears could put children at risk of predators, have told Sky News they are developing tools "to avoid deviant behaviours".

Yellow has been compared to the dating app Tinder, as user's swipe right and left on profiles to connect with strangers. Unlike Tinder, which has a minimum age of 18, Yellow has no age checks.

Under 18s can only speak to other under 18s on the app, but there's no mechanism to stop adults lying about their age and pretending to be children.

How to report to the Child Exploitation and Online Protection Centre CEOP

CEOP works with child protection partners across the UK and overseas to identify the main threats to children and coordinates activity against these threats to bring offenders to account. We protect children from harm online and offline, directly through partnerships with local and international agencies. Please see below some additional guidance from CEOP in regards to what to report;

- 1. Someone online was threatening me and made me feel unsafe.
- 2. Someone online asked me to send them nude images.
- 3. I shared a nude image with someone online and they threatened me.
- 4. I was worried someone I was talking to online was dodgy.
- 5. I did something that I was embarrassed about on webcam and then I felt really worried.
- 6. Someone online kept asking me to meet them face-to-face, and I didn't want to.
- 7. Someone online was talking to me about sex and made me feel uncomfortable.
- 8. Someone online put pressure on me to do things I didn't want to do.
- 9. Someone I met online was sending me pornography and making me feel uncomfortable.
- 10. Someone I met in an online game kept trying to talk to me privately.

Please may I remind parents that the report button can also be used to raise concerns regarding bus travel to and from College? The information provided will be used to enforce the Local Authority's 'code of conduct'.
